# III. Board Discussion of Work Session Topic

**BOE Comments on WS Topic** 

- President Mininsky complimented Ms. Mule and staff on its wonderful presentation; asked where additional monies could be found in the budget (rolled over into following year, deferred revenue).
- Board Member Vrona asked about the waiting list (15-25 for day; 35 for night mostly ELLs who work during the day; every class has a waiting list); asked if the DOOR program was open to Long Beach school district people not just Long Beach residents (yes); how many students in the SNAP program (50-70 per year); union 1199 is no longer affiliated- on-line (doesn't need program); how many participants in Literacy Zone (200) and how do people find out about it (flyers, word of mouth, social media); how many people in the Parent-Child program (10 families capped); completely funded (yes); is employee funding determined by state (yes); would expenditures increase with additional students (already had staff reductions); would more space increase classes (yes); needs to see space; questioned participants in continuing ed (fall and spring about 495: need flexibility for rate of wages for teachers; classes never run without making profit); asked about costs of staff in program (projected vs. factual); put "up to" on agenda.
- Vice President Tangney thanked everyone for the presentation which answered a lot of questions; noted that any time she walked into ALC there was a passion and dedication and pride; highest level of leadership; Ms. Mulé has expanded the program; it is her favorite graduation; great stories; what timeframe has the most students (lowest level at night since many students work during the day); asked if they had considered using a Long Beach school at night (transportation is problematic, need resources, dependent on school: they really need to have a home); split location won't work (no). Asked if we ever had an expenditure line in the budget (no need since they are self-funded).

- Gloria Ferrera staff member 18 years ago fell in love with Adult Learning Center; got HS diploma; passed citizenship exam, now a staff member; pleaded for new home for program.
- Lena Walker student came to NY from Virginia during Brown v. Board of Education period; program means everything to her.
- George Richardson received his HS diploma this week; grateful to staff, BOE; came from Jamaica with no hope and teachers showed him he could be useful; proudly posted his diploma on the internet; ALC is the best; wants to give back.
- Allan Payne attended other programs but never received the attention he got at ALC; unlike other programs that only focus on those they expect to succeed; commutes every day from Rockaway; teachers extend themselves beyond their limits; they deserve better facilities.
- Ana Cabrera started program in September; need to learn English; everyone helps you there; has a lot of dreams.

Mr. Weiss has been looking for a new location since Superstorm Sandy; trying to cut a deal with landlord; maybe tax break would help; someone needs to donate property.
