- The 2025-26 Special Education Program Proposed Budget includes:
  - Inclusion of occupational and physical therapists in A2250.160 (staff were formerly included in a grant and now a proposed new assistant director and psychologist will be in the grant instead)
  - Inclusion of speech teachers in A2250.121 and A2250.131 (staff were formerly included in a grant)
  - Funding for Reach counseling services has been eliminated from A2250.442-00-0000



- The 2025-26 Special Education Program Proposed Budget includes:
  - Funding for students who currently attend programs in public schools in other districts [A2250.470-00-0000] has been eliminated since no students are projected to attend those schools next year (current students have completed the program)
  - A decrease in out-of-district school placements [A2250.471-00-STIP] based on the fact that the agreements for a few of these students end at the close of the current year
  - An increase of three additional students projected to attend non-public schools [A2250.471-00-0000]



- The 2025-26 Special Education Program Proposed Budget includes:
  - A decrease in projected BOCES placements somewhat offset by an increase in expected related services [A2250.491-00-0000]
  - A reduction of one special education teacher at LBHS
